

**CONSUMER WARRANTY SPECIAL TERMS  
FOR INVERTER MOTORS  
of Electrolux and AEG products**

1. The general terms and conditions of consumer warranty for the products of Electrolux and AEG can be found on [www.electrolux.ee](http://www.electrolux.ee) and [www.aeg.ee](http://www.aeg.ee). The general terms and conditions of the consumer warranty apply in all aspects related to the warranty aside from the special conditions noted below.
2. For deficiencies of the inverter motor of Electrolux and AEG washers/dryers manufactured from 2 August 2013 onwards, an extended 10-year warranty is available, if the warranty is activated by the customer in accordance with the below, and other requirements stipulated in the general terms and conditions of the warranty are met. Other deficiencies of the product are not covered by the current special conditions of extended warranty.
3. Customers can activate the 10-year extended warranty for inverter motors after the purchase of the appliance by registering the product at [www.electrolux.ee](http://www.electrolux.ee) or [www.aeg.ee](http://www.aeg.ee) within 3 months of the date of purchase. If the product is not registered in due time, the extended warranty as per the current special terms and conditions of warranty do not apply.
4. These terms have been construed in English language and thus Estonian language is of informative nature.

**INVERTERMOTORITE TARBIJAGARANTII  
ERITINGIMUSED  
Electrolux ja AEG toodetele**

1. Electroluxi ja AEG toodete tarbijagarantii üldtingimused on avaldatud [www.electrolux.ee](http://www.electrolux.ee) ja [www.aeg.ee](http://www.aeg.ee). Tarbijagarantii üldtingimusi kohaldatakse kõigis garantiiga seotud küsimustes, välja arvatud allpool toodud erisustes.
2. Alates 02. augustist 2013. a toodetud Electroluxi ja AEG pesumasinate/kuivatite invertermootorite puudustele pakutakse pikendatud 10-aastast garantiid juhul, kui klient aktiveerib garantii vastavalt alljärgnevale ning muud garantii üldtingimustes sätestatud nõuded on täidetud. Käesolevad pikendatud garantii eritingimused ei hõlma toote muid puudusi.
3. Kliendid saavad invertermootorite 10-aastase pikendatud garantii aktiveerida pärast seadme ostmist, registreerides toote veebilehel [www.electrolux.ee](http://www.electrolux.ee) või [www.aeg.ee](http://www.aeg.ee) 3 kuu jooksul arvates ostukuupäevast. Kui toodet ei registreerita tähtaegselt, ei kohaldata pikendatud garantiid vastavalt käesolevatele garantii eritingimustele.
4. Käesolevad tingimused on koostatud inglise keeles, eestikeelset versiooni loetakse informatiivseks.
